Pawfect Love Pet Care reserves the right to refuse service and I have disclosed this behavior with my Pawfect Love Pet Care representative.

I have also read, understand and agree to the following:

Terms and Conditions

The utmost of care will be given in watching both your pet(s) and your home. In consideration of these services and as an express condition thereof, the Client expressly waives and relinquishes any and all claims against Pawfect Love Pet Care except those arising from negligence of Pawfect Love Pet Care.

Client agrees to notify Pet Sitter/Pawfect Love Pet Care of any concerns within 24 hours of client's return home. Pawfect Love Pet Care cannot be held responsible for any mishaps, claims, and/or expenses attributed to a destructive or unpredictable behavior of the Client's pet(s) that cause damage to the Client's home/property and/or a neighbor's home/property. (i.e. biting, furniture damage, accidental death, etc.) Nor can Pawfect Love Pet Care be held liable for injury, disappearance, death, or fines of pet(s) with access to the outdoors.

Before any service will be rendered all paperwork must be duly provided to Pawfect Love Pet Care, including: Client Agreement, Client/Pet Information Form, Veterinary Release Agreement, and a copy of recent veterinary vaccination certificates if applicable.

Fees/Charges

Visit(s) made or services performed shall be paid for at the agreed rate, with Client taking full responsibility for prompt payment of fees. A finance charge of 5% per month will be added to the unpaid balances after 30 days. A handling fee of \$30.00 will be charged on all returned checks. In the event it is necessary to initiate collection proceedings on the account, the Client will be responsible for all attorney's fees and costs of collection.

Emergencies

Pawfect Love Pet Care is authorized to seek emergency veterinary assistance if needed during visits, at the cost of the Client, from their personal Veterinarian or one chosen by Pawfect Love Pet Care, if after hours or Veterinary office is closed as outlined in the Veterinary Release Agreement.

In the event of a personal emergency or illness of the designated Pawfect Love Pet Care Pet Representative, Client authorizes Pawfect Love Pet Care to arrange for another qualified pet sitter/company to fulfill pet sitting responsibilities. Client will be notified in such a case. All terms and conditions set forth on this contract will apply to replacement Pet Sitter and Client.

In the event of inclement weather, natural disaster, or national emergency, Pawfect Love Pet Care is entrusted to use their best judgment in the caring for Clients' pet(s) and home. Pawfect Love Pet Care will be held harmless for consequences related to such decisions.

Client agrees to reimburse Pawfect Love Pet Care for any additional fees for tending to emergency or veterinary care as well as any expenses incurred for same. Every effort will be made to contact the Client prior to obtaining emergency care.

Termination/Authorization

Pawfect Love Pet Care reserves the right to terminate service at any time before or during scheduled service, if Pawfect Love Pet Care in its sole discretion, determines that Clients' pet poses a danger to the health or safety of the Pawfect Love Pet Care Representative.

In the event of an injury, Client will be responsible for all medical expenses and damages resulting from the injury to the pet sitter, other persons, or other animals by the pet. Client agrees to indemnify, hold harmless, and defend Pawfect Love Pet Care in the event of a claim by any person or legal entity injured by the pet.

If concerns prohibit Pawfect Love Pet Care from caring for the pet(s), Client authorizes pet(s) to be placed in a boarding kennel, unless otherwise specified, with all charges from there to be charged to Client. It is the express policy of Pawfect Love Pet Care to attempt to contact the Client in the event of unforeseen change in circumstances that affect the ability to perform requested services.

Security

Pawfect Love Pet Care agrees to use reasonable care with all security information it is given by the Client, including but not limited to keys and security access codes. Property security will remain the responsibility of the Client. In the event that Pet Sitter/Pawfect Love Pet Care is given security access it agrees to re-secure the property in the condition that it was in prior to its arrival. Any malfunction in property security will remain the responsibility of the property owner.

Client expressly gives Pawfect Love Pet Care the authority to employ a locksmith on their behalf and to reimburse Pawfect Love Pet Care promptly upon their return for all costs incurred in the event of malfunction of the lock, keys or automatic door opener.

Pawfect Love Pet Care cannot service a home with "visiting pets" or animals that do not belong to the resident of the service site without a separate written agreement. As such the terms of this agreement apply only to pets owned by the client.

If any friends/neighbors/family members will be entering your home while it is under our care, Pawfect Love Pet Care must be notified in advance. The assigned Pawfect Love Pet Care Representative will not enter an occupied home under any circumstances that we have not previously been made aware of, nor will we allow entry to any person we have not been made aware of. Pawfect Love Pet Care will not be held responsible for any damages incurred to your home or pet(s) by said visitors. It is understood that anyone with access to the home will be notified of the Pet Sitter/Pawfect Love Pet Care presence and vice versa. The police will be called on all intruders or suspicious acts without exception.

Agreement

Client agrees that the provisions of this form are valid approval for future services of any purpose provided by Pawfect Love Pet Care. This agreement will remain valid and in effect for as long as the undersigned remains a Pet Sitter/Pawfect Love Pet Care, permitting Pawfect Love Pet Care to accept telephone, and email reservations for services and enter Client premises without additional signed contracts or written authorization.

Client agrees to provide Pet Sitter/Pawfect Love Pet Care with a phone number where they can be reached while away. Client will also provide a phone number of another person to contact who is authorized to handle any major problems that may occur while away. If Client or the other contact person cannot be reached, Client agrees to accept any decision Pet Sitter/Pawfect Love Pet Care makes in regards to the pet's care or Client's property. Pawfect Love Pet Care agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the Client expressly waives and relinquishes any and all claims against Pet Sitter/Pawfect Love Pet Care except those arising from negligence of Pawfect Love Pet Care. Client agrees to notify Pawfect Love Pet Care of any concerns within 24 hours of return.
